- v) **You agree to umpire as directed by the current Men's or Women's Vice President or organise a suitable replacement in the event you are unable to fulfil your umpiring commitment (umpiring fines incurred by the club for non-attendance by any assigned umpire will be invoiced to the offending player together with the designated club umpiring fine).**
- vi) **PAYMENT OF FEES: All fees must be paid by the 30th April (unless a payment arrangement has been made with the Club Treasurer). You acknowledge that should your fees still be outstanding at this time, you will not be eligible to play any further games until your fees have been paid in full. A discounted fee will apply if fees are paid in full on Registration Day**
